RE: ILLEGAL INTIMIDATION OF PETITIONER'S WITNESSES AND CONVENING OF ILLEGAL LCI COURT TO TRY THEM

ELECTION PETITION NO. 08 OF 2026

HON. ARINAITWE RAUBEN VS TUMWESIGYE ANTHONY AND THE ELECTORAL COMMISSION

We act for and on behalf of the above-named Petitioner. The Petitioner has also placed in our able hands your illegal summonses, the most recent dated 9/5/2026, summoning our client's witness called Mrs Bamukunda Saidat who swore an Affidavit in support of the Petition. (Copy of Letter attached as "A" for ease of Reference). It is also reported that you as Tumwesigye Anthony's Agent has been issuing death threats against the Petitioner and his Witnesses which we strongly condemn and object to as follows:

1. Issuing a death threat to our Client and his Witnesses is an offence to be prosecuted.
2. The subject matter of your summons being "To appear in the LCI Court to Answer to charges of telling lies against people concerning elections". If you, your alleged complainants, Tumwesigye Anthony for who you have been an Agent; and his Lawyers genuinely believed that there were any lies the Petitioner's said witness told, they would have challenged them for the High Court to determine. The LCI Court, which you are illegally convening without jurisdiction, does not have the jurisdiction to hear matters before the High Court of Uganda. You and your co-conspirators led by Tumwesigye Anthony commit offences contrary to Sections 88, 90 and 94 of the Penal Code Act.
3. In your purported summons, you also prejudicially give our client's said witness an outrageously short notice of less than a day to appear before your Kangaroo Convened Court on Sunday 10/5/2026 at 3:00 p.m. This is an illegal venue of a Civil Servant, one Bamutungyere Joramua alias Tibaremwa who is the headmaster of a government Primary School called Kishami Primary School.

4. You also purport to write in a position of Chairman LCI which you are not, which is impersonation contrary to Section 354 of the Penal Code Act.

We accordingly bring it to your notice that;

1. Stop all crimes as highlighted above.
2. The Petitioner's witness has been advised not appear before your illegally constituted Kangaroo Court to aid and abet your illegalities.
3. Forthwith stop offences of intimidating witnesses.
4. Forthwith stop Contempt of Court to interfere with an ongoing Subjudice Petition before a Court of Law.
5. We shall institute proceeding against you, those who will attend the illegally convened Court and the host, Tumwesigye Anthony and his lawyers of M/S Ngaruye Spencer and Company Advocates who are perpetrating the above offences.
6. By copy of this Letter, notify Police to investigate, stop your illegalities and cause prosecutions.
